## Summary

Fiscal Year 2025 was a year in which nothing was certain but change and more change! We started the year with a new State Librarian, drastic changes in Enoch Pratt Free Library senior leadership and fires under the streets melting crucial cabling. Then came the US Presidential Election which disrupted any hope of funding stability nationally, statewide, and locally. We went into the Legislative Session as a well-prepared team, but ultimately lost our bid for additional funding in FY26. We negotiated major new contracts for our statewide Interlibrary Loan software and for a new selection of Gale databases for the consortium. Through all of this, we continued to provide the people of Maryland with exceptional access to resources, guided by our expert staff. We held four statewide conferences, which were better attended than almost any in the past, and we established new relationships with local institutions of higher learning. We held our first joint conference with the Maryland Library for the Blind and Print Disabled, which was an excellent experience both for the planning teams and the attendees. Digital Maryland added almost twice as many items to their collection this year as ever before. While we are confident that Fiscal Year 2026 will lend a bit more stability to our leadership and our processes, we are excited that many new ideas sprang from the chaos of FY25 and that even with less funding we will see increases across all numbers.

## Organizational Effectiveness

Organizationally, FY25 was a time of great change and transition for the Enoch Pratt Free Library and State Library Resource Center. The union contract between staff and AFSCME continued to be negotiated, and new services were launched. Chad Helton, the new CEO & President understands the importance of SLRC and has had several meaningful conversations with Morgan Miller, State Librarian. Since Liz Sundermann-Zinger, Chief of SLRC, was already handling statewide SLRC legislation, had been working with Pratt's lobbyists, and was the chair of the Maryland Library Association's Legislative Panel, it was practical and effective to shift her into the role of the EPFL/SLRC legislative liaison to the Pratt Board when Meghan McCorkell left the organization.

- In October 2024 Interim CEO Darcell Graham left the organization for another role.
- At the same time, new CEO & President Chad Helton joined the Enoch Pratt Free Library and State Library Resource Center (EPFL/SLRC).
- Key vacancies at EPFL/SLRC this year included: Chief of Marketing, Communications, and Strategy, Chief of Human Resources, Chief Operating Officer, Chief of Neighborhood Library Servies, Chief of Digital Transformation, and Vice President of Public Services.
- Roles that were filled in FY25 include: CFO, Sri Veeramacheneni; Special Assistant to the CEO, Lauryn Reynolds; Director of Public Safety, Patrice Williams; Social Science & History Manager, Amanda Hughes; Teen Department Manager, Zoe DiGiorgio.
- Liz Sundermann-Zinger, Chief of the Central Library and State Library Resource Center took on the role of Legislative Liaison to the Board.
- Due to staffing shortages the Maryland Department shifted to appointment-only status between 5PM and 8PM on weeknights.

#### **Awareness**

State Librarian Morgan Miller and State Library Resource Center Chief Liz Sundermann-Zinger worked with all relevant statewide library groups as well as two lobbying firms to ensure that the Governor's Office and the General Assembly are aware of the importance of increasing SLRC funding. The introduced bill did not pass, but conversations with the government have occurred continually throughout the year, before, during and after the legislative session.

- The Maryland State Library Agency (MSLA) and the Maryland Association of Public Library Administrators (MAPLA) submitted letters for additional SLRC funding to be included in the Governor's budget.
- The Chief of SLRC and the State Librarian held meetings with Maryland Senators Guy Guzzone and Ben Barnes to raise awareness of SLRC's needs
- MSLA, MAPLA, and SLRC worked with lobbyists and State Delegate Dana Jones and State Senator Nancy King to craft and put forward legislation to increase SLRC funding.
- Digital Maryland held meetings with the Maryland State Archives on January 7 and February 10 and attended the Digital Public Library of America 2025 Kickoff.
- Digital Maryland, the Special Collections Department, and the Maryland Department are working closely with the MD250 Commission in order to support that project and raise awareness of our collections.
- SRLC regularly publishes stories about conferences and Digital Maryland in *The Crab*, the Maryland Library Association newsletter.
- SLRC staff presented at the MDLibTech Conference and the Maryland Library Association Annual Conference.
- The Chief of SLRC participated in all MAPLA meetings, attended and was active in their Inter-governmental relations task force.
- The EPFL CEO and President as well as the Chief of SLRC attended the Citizens for Maryland Libraries annual meeting.

### Higher Education Outreach

In FY25 SLRC staff across departments focused much more intentionally on providing outreach to institutions of higher education. Through a combination of increased visits to increase awareness of SLRC programs, resources, and services and increased participation in intentional networking we have established many new connections.

# Technology

#### SAILOR Fiber Network

- Statewide Internet was down for several days due to the fire under Charles St. in Baltimore.
- A redundant fiber Point of Presence (POP) is being constructed at the City Municipal Building.
- The Leonardtown POP in St. Mary's County is up, and the SAILOR router has been installed.
- The new Eastern Shore Regional Library POP was completed this year.
- The Hagerstown connection is still an issue that Comcast needs to resolve. We are waiting for fiber to be built into downtown Hagerstown.
- The Kent County connection is being upgraded to 2.5Gbps to support Kent County Public School's needs.

#### Marina Interlibrary Loan

- The current resource sharing platform, Relais D2D, is being sunsetted by OCLC.
- An RFP was launched November 4th and three vendors responded.
- After statewide participation in the selection process, Auto-Graphics, Inc. was selected to replace Relais during FY26. There will be a slow and intentional transition process.
- Statewide Delivery Services signed a new three-year contract with Hub City Express, Inc. for connections to Western Maryland, Frederick County, Montgomery County, Prince Geroge's County, and Southern Maryland.

- It was a contract renewal year for the SAILOR database contracts.
- A vendor fair was held in September that included nine vendor presentations.

#### Reference

In Fiscal Year 2025, SLRC staff answered 267,704 reference questions, which is down from FY 2024 when we answered 302,099. Numbers are down overall, with the exception being the Children's Department which answered significantly more student questions than last year. Some of the drops are due to the Maryland Department now being appointment-only after 5:00 due to staffing issues and fewer technology questions being answered by SLRC staff due to the presence of full-time Digital Navigators.

# Fiscal Report

This fiscal year the State Library Resource Center spent 98% of our total budget within the Enoch Pratt Free Library system. It should be noted that we spent all of the \$12,760, 846 provided by the State of Maryland and supplemented \$1,799,946 with EPFL's general fund. This has been a standard practice for many years because the State allocation is not enough to remain operational. The Executive Direction expenses are elevated due to vacation payouts for vacated leadership positions, and other payouts made to previous executives were reported in the Administrative and Fiscal Services section.
