#### **Network Videoconferencing Equipment Use Guidelines (Tom Hehman)**

The *Videoconferencing Equipment Use Guidelines* were adopted by Wicomico on 12.12. 07.

Tom said that the next challenge was to market this opportunity, especially to Senator Stoltzfus who made the recommendation to expand the use of the service.

It was pointed out that the Capital does not have any type of videoconferencing system. networkMaryland is considering for the far distant future.

It was suggested that AACPL be added to the video conferencing network for use by legislators. DLDS could possibly provide grant funding for this project. Sailor would help select and acquire the equipment. Harford County volunteered to be a test site.
