FY 2021 SLRC Annual Report

The SLRC Annual Report responds to the FY 2018 to FY 2021 State Library Resource Center Strategic Plan. SLRC's Core Purpose is to provide cooperative, cost effective, statewide resources and services to Maryland libraries and their customers in collaboration with its partners.

Awareness

All Maryland libraries are aware of SLRC resources and services.

Action steps:

Reformat the established SLRC Liaison in the new environment reassessing the SLRC support needs of Maryland public libraries with an emphasis on rural libraries. Enhance connection of SLRC resources and services to rural libraries in Maryland. SLRC Strategic Plan Objective 1.1: Expand awareness geographically with emphasis on rural, suburban, and urban areas. (L)

A meeting with Dana Newman and Scotti Oliver took place on February 9, 2021 exploring the Talbot County Free Library's participation as part of the SLRC Liaison Program. Dana Newman and Scotti Oliver prepared a document that created a valuable agenda and conversation.

Talbot County Free Library Priorities for TCFL

- Training: Assist in planning ongoing, annual, required staff training.
- Human Resources
- Help with improving staff and public communications
- Assistance with grants.

The Training and Grants areas are the initial areas where SLRC will be able provide assistance. The Human Resource and Communications areas are those where SLRC will work with Dana and Scotti to locate helpful resources.

Homeschooling:

Survey conducted of homeschool communities statewide: Children's staff assessed the needs of homeschoolers and students learning from home across the state by administering a survey through co-ops, county library email lists, and Facebook groups. The survey had 204 responses sharing feedback on what services these students need from their library. (Appendix 2)

Homeschool survey results compiled in a report and shared with county library systems: Children's and teen staff examined the results, found trends, and shared those trends in needs with library systems across the state.

A student support webpage is being planned and developed. Library staff will be able to go on to slrc.info for resources that meet the needs of homeschoolers, traditional students, and distance learners in their county.

Awareness through conferences and meetings:

Maryland Genealogy Conference

The 2020 Annual Genealogy Lecture Series with Tony Burroughs took place virtually on October 24, 2020. This was rescheduled from its original March date due to Covid-19. There were 129 attendees. Evaluations were completed and highly favorable.

Genealogy Circle Meetings

The Library continues to hold Genealogy Circle Meetings four times a year. Most recently, we held one on researching military records on November 17, 2020, and one on researching land records on December 5, 2020. Both events were held virtually and archived.

Maryland Statewide Circulation Conference

The Maryland Statewide Circulation Conference was held virtually January 26-28, 2021. There were 565 registered participants this year, more than doubling any previous SLRC hosted conference on record. This year's conference included topics in customer service, resiliency, wellness, and trauma-informed training for the library workforce.

Expand the visibility of SLRC resources by continuing traveling exhibits featuring resources and special collections from the SLRC collection and creating shareable virtual programming from Library social media channels, including Special Collections highlights. Enhance connection of SLRC resources and services to rural libraries in Maryland. SLRC Strategic Plan Objective 1.1: Expand awareness geographically with emphasis on rural, suburban, and urban areas. (L)

Special Collections:

Three Traveling Trunk Exhibits featuring manuscripts facsimiles from the Library's Edgar Allan Poe Collection are available to be loaned across the state.

Special Collections participated in the International Edgar Allan Poe Festival and Awards by contributing 20 minutes of video highlighting the library's Poe collection and its provenance. The videos were streamed over the course of the weekend of October 3rd and remain online via the Poe fest website and YouTube.

Implement effective virtual communication and marketing techniques enhancing the awareness and visibility of SLRC. Strategic Plan Objectives 1.3: *Expand the awareness of SLRC services to Maryland library staff at all levels (I).*

Web Visibility:

The Library's new web page was launched August 24, 2020 creating a more graphically exciting experience for customers and dramatically increasing the visibility of Library resources. The top-level page highlights services, resources, and programs for customers by age area of interests. All important information and resources buttons appear at the top of every page eliminating the need to back click making browsing easier.

Library programs, Readers Advisory and subject related presentations are available through Facebook Live and Crowdcast.

An inventory of the slrc.info web site was conducted as a first phase in the sites redesign. The redesign will not only improve access to the site it will allow for improved editing and updating of the pages content data. The analytics provided by the Web Department allow for the removal now of pages that have little or no traffic. Redesign work will begin in late spring.

Additional:

- The MILO department is now holding bi-weekly meetings for the Marina Users Group so
 that staff throughout the state will be promptly updated and can have any concerns and
 training needs addressed immediately. MILO held their first virtual Marina branch training
 on September 3rd, 2020. Marina training will continue virtually to meet the needs of ILL
 staff. The Marina User's Group will be reviewing MILO's current training program to help
 refine and update as needed.
- As of September 28, 2020, all Marina libraries have resumed borrowing and lending service via Marina.
- The Marina Users Group was given the current MILO marina training over the course of 2
 Users Group Meetings and has provided feedback as to what they believe could be
 improved.
- On December 10, 2020, Representatives from Relais/OCLC attended the Marina Users
 Group meeting to present upcoming Marina specific software updates or a "road map" from
 Relias. Relias/OCLC will be presenting this "road map" quarterly to Marina Users Group.
 This will provide an opportunity for Marina Libraries to contribute recommendations and
 receive training directly from the vendor.
- MILO staff presented at the virtual Circulation Conference this year with 212 people in attendance.
- MILO will be sending out RFPs to potential vendors for resource sharing software. Demos
 will take place during the Marina Users Group Meetings in April and a vendor will be
 selected by May 2021.
 - Autographics provided a demonstration for the Marina Users Group on April 8, 2021
 - OCLC Relais gave a D2D demonstration on April 22, 2021
 - Feedback has been received as well as the responses to the RFPs from the vendors. These will be reviewed with a decision by the end of May 2021.
- Feedback from the Marina consortium lead to the renewal of the Relais contract providing interlibrary loan service software. Participants in the demonstrations decided that overall, Relais best suited everyone's needs.

The Autographics proposal exceeded budget. The decision reflected confidence with the Relais product and its ability to meet interlibrary loan needs. Relais can provide interoperability between what will be four different ILS. Relais will refine workflow this fall during the re-implementation to ensure that system setup meets everyone's needs.

LibAnswers with LibChat:

The Virtual Reference Coordinator guest spoke at the University of Maryland iSchool's Serving Information Needs course about developing virtual reference services to benefit the public's research and service and staff's professional development needs.

- The following counties have reached out to the Virtual Reference Coordinator for guidance on researching and developing their virtual reference services:

 - The following county reached out about accessing our service for chat and email school research project purposes: Harford (January and February)
 - A two-day, eForum was coordinated and presented jointly by RUSA's Reference Services and Emerging Technologies Sections on March 2 and 3, 2021. The eForum was entitled, "From a New Normal to a New Future: eForum on Trends in Virtual Reference & Emerging Technology."
 - Paul Chasen provided a chat training session for the Charles County Public Library Staff Development Day, April 32, 2021. The training was entitled, "It's All In the Words and Pacing: Providing Professional Online Chat Customer Service at Your Library."

Note:

Customer use of chat during the pandemic year mimicked the experience the former AskUsNow service saw. The current LibChat service is accessible from the Library's webpage and is being used by customers throughout the state. The significant change seen in the use of the service is reflected in the increase in Level 4 research questions. Eight-five percent of questions handled are Level 4.

Increase visibility of Sailor databases and e-resources among MD public electronic resource librarians, public library staff, K-12 teachers and school librarians through the 3rd annual Sailor Symposium (to be held virtually for the first time). Strategic Plan Objectives 1.3: Expand the awareness of SLRC services to Maryland library staff at all levels (I).

SAILOR/Gale Resources and ELL and Accessibility Support /Co-Presented with Stacey Knibloe (Gale): Maryland Association of School Librarians Oct 16,2020

 The presentation included a brief description of SAILOR's role providing electronic resources for public libraries statewide in alignment with the public school (K12) community. The workshop focused on accessibility tools available for a wide variety of student needs.

Sailor Databases

- A timeline and framework for the next round of SAILOR database renewals is being developed. The existing contract will expire in June 2022. The timeline will include an RFP, vendor presentation and a survey for the MPERLS group.
- A timeline for the SAILOR Database contract negotiation has been developed. our goal is to have final selections made by February 1, 2022, announcements made in March and to have any new resources available by June 31, 2022.
- To start the process a survey was developed designed to solicit information on what sorts
 of electronic resources our stakeholders find most useful for their community groups. The
 survey was intentionally broad and not limited to just existing SAILOR resources. The
 survey was sent to the MPERLS list, MAPLA and MaryLib. A slightly different version was
 sent to K-12 Library Media Specialists. The surveys will close on May 28th.
- A Virtual Vendor Fair will be held in early September 2022 to showcase potential new products and to receive updates from existing vendors. Vendor Fair attendees will be asked to provide feedback on the resources.
- The next phases of the SAILOR Database project will include:
 - Development of a communication plan that will be shared with the MPERLS group and other key stakeholders. This plan will identify key points at which we will share the status of the project and get feedback from the group
 - o Reviewing survey results and identifying key areas of interest and need
 - o Reviewing the RFP to identify areas that should be updated to reflect current needs

Sailor Symposium:

Planning continues for a virtual SAILOR Symposium. The symposium will be a virtual presentation Thursday-Friday December 3rd-4th.

- The Save the Date (Oct 9th) and Registration announcements (Nov 5th) have been sent to multiple list serves. The Symposium agenda including the Presenter's biographical information and workshop descriptions was included in the registration announcement and will be available on the event website. (in progress). Registration to date: 80 Keynote speaker Gary Price has affirmed his participation. The honorarium check request is in process. Laura Hicks (Dept. of Education) Lo Smith (EPFL/SLRC) and Adam Bouhmad (Project Waves) will present workshops. Sailor Database Project related vendor updates will also be presented.
- Topics at the symposium will include: Information Literacy, Openly- licensed Educational Resources, Privacy Online, vendor updates as well the changing focus of electronic content.
- A pre-symposium MPERLs Only Conversation is also scheduled on Dec 2nd. The
 conversation agenda will include a discussion of the SAILOR contract related electronic
 resources: Mango Languages, PQ HeritageQuest and Gale resources.
 Additional topics may be added.

Our third annual SAILOR Symposium held December 2nd-4th was also our first all virtual Symposium. We kicked off with an MPERL meeting which included roughly 50 e-resources librarians from across the state. We discussed the current status of the SAILOR database project, how COVID had affected the database stats and anticipated steps for our next round of contract negotiations. MPERL members voiced concern about the contract length (preferred a 4–5 year contract to a 3 year) and reiterated the importance of user-friendly mobile access.

Conference

- For the main conference we had 121 registered attendees and 4 sessions. Generally, less than half the people that registered attended each session which is fairly standard. Many people register with the intent of watching the recordings later.

Evaluations

SAILOR Database Selection Project

Our current SAILOR statewide database contracts end on June 30th, 2022. The selection process officially kicked off this spring and includes multiple components including a state-wide survey, a vendor fair, several MPERL meetings and an updated Request for Proposals.

The SAILOR Database E-resources Survey was conducted in May of 2021. Two surveys
were created to capture feedback from the main SAILOR database user groups, public
libraries and K-12 public schools. We contacted three groups to respond to our survey:
Maryland Electronic Resource Librarians, participants on the Maryland Library Association

listserv and Maryland K-12 representatives. Our group of respondents included: 85 public library responses and 36 K- 12 responses.

The survey results show strong support for literacy and school support from both public libraries and public schools. 88% of all respondents rank it as Important to Very Important. While there is some divergence in opinion between public libraries and K-12 schools, there is much in common. Public libraries overall rank Online Learning higher than schools did, for example, but Online Language Learning individually has strong overall support. Other areas of strong interest include Family History, Job and Career resources, and General Research support, e.g. newspapers. STEM support, and based on comments in the survey, specifically Math is an area of strong interest as is Test Prep including for the GED.

The key features of electronic resources most valued by those surveyed are: visual appearance, ease of authentication, and mobile access. The key issues strongly reported are: Privacy, ADA Compliance, and Diversity/Social Justice.

SAILOR Symposium 2021, E-Resources Vendor Fair, August 31st-September 1st

Planning is well underway for the 2021 SAILOR Symposium. This event will once again be entirely virtual with a focus on vendor presentations. The presentations fall into two categories, vendors under consideration for inclusion in the SAILOR database project and vendors that have products that had high levels of interest based on the survey results.

Digital Inclusion

Through SLRC, Maryland libraries have access to digital resources and technology to achieve digital equity statewide.

Action Steps:

Expand awareness of Digital Maryland through statewide conference and event participation. SLRC Strategic Plan Objective 2.4 Increase awareness of Digital Maryland and maintain support of local digitization efforts. (I)

- Historic Maryland Newspapers Project Annual Meeting- Update meeting regarding the grant funded project to digitize Maryland historic newspapers as part of the Library of Congress Chronicling America project, October 28, 2020
- Maryland History and Culture Collaborative- Meeting for Maryland cultural institutions across the state, November 9, 2020
- Oral History Collaboration- Meeting to explore ways Digital Maryland could help support oral history initiatives across the state, November 9, 2020

- Met with McDaniel College to discuss becoming a Digital Maryland partner, January 8, 2021
- Met with Natural and Historical Resources Division NHRD Public History Roundtable (PG County) to discuss the Digital Maryland Project, January 11, 2021
- Met with Jewish Museum of Maryland to discuss oral history collection for potential inclusion in Digital Maryland, January 13, 2021
- Provided ContentDM training for Frederick County Public Library staff, February 12, 2021
- Met with Maryland Art Place to offer advice as they start to pull materials for their Digital Maryland Project. Anticipated collection launch is summer 2021, February 26, 2021
- Met with representatives from Marion House, a non-profit organization that recently purchased the Women's Industrial Exchange Building. The WIE archives are still in the building and they are interested in a potential partnership with Digital Maryland, March 17, 2021
- Met with a group of community archivists who have secured signs that were hung on the Black Lives Matter Memorial Fence in Washington, DC during the summer of 2020. We discussed ways to make the collection accessible. March 24, 2020
- Met with Mid-Atlantic Moving Image Archive to discuss possible partnership opportunities.
 April 2, 2021
- Digitization staff attended the Africana Collections and Cultural Programs Symposium II sponsored by the Billie Holiday Project. The Symposium outlined the needs of Black archives in Maryland and ways Digital Maryland may be able to support preservation and access efforts, June 3-4, 2021

Build diverse collections in Digital Maryland and explore new format options while maintaining support for our local partners. SLRC Strategic Plan Objective 2.4 Increase awareness of Digital Maryland and maintain support of local digitization efforts. (I)

Oral History Collection:

- In collaboration with Digital Maryland, Special Collections has developed a new program to collect, preserve, and digitize oral history collections. The MRHC Collection comprises oral history interviews of LGBTQ+ people living in Maryland, including the founders of a number of early lesbian and gay rights organizations in Baltimore.
- The Maryland Rainbow History Collection is now live and has been promoted through programs and via social media. https://collections.digitalmaryland.org/digital/collection/mdrh

Note:

Save a Story: DIY Oral History Kit with Digital Audio Recording Kit and User Guide

A new initiative creating digital recording equipment kits that will be available Library customers as well as to Maryland public libraries and organizations. The kits support the Oral History DIY training and public program current in place. Training sessions for the use of the kits along with the principles of oral history recording will be provided by SLRC Special Collections staff.

New Digital Maryland Collections and Additions to Existing Collections:

- Somerset Public Library Vertical File: Working with Somerset County Public Library to
 present their vertical file collection on Digital Maryland. This collection features news
 articles, community newsletters and other ephemera relating to the Maryland Eastern
 Shore and Somerset County.
- Carroll County History Project: Updated over 300 links to oral history videos created by the Carroll County Community Media Center. Started discussions to add more of this collection to Digital Maryland with a focus on the oral histories in the "Through the Eyes of the Black Experience" and "Carroll County Veterans" playlists.
- Black Lives Matter: Protest Signs from the Reginald F. Lewis Museum: Collection of 50
 Black Lives Matter protest signs donated to the museum. The signs were scanned by
 Digital Maryland and the collection is now live on Digital Maryland and has been promoted
 via social media.
- African American Funeral Program Collection: This collection now has nearly 2,500 items fully described, transcribed and uploaded. Remaining programs have been scanned and we are working to transcribe pages and provide metadata for the remainder of the collection.
- Sandy Spring Archives: Our partner institution continues to aggressively scan and add materials to their collection. The collection now includes over 900 items many of which are ledger books, autograph books or other multipage items.
- Surratt House Museum, Clinton Maryland- update and introduction meeting September 12, 2020
- Blacks of the Chesapeake/Maryland State Archives- met to discuss hosting some portion of this collection on Digital Maryland November 4, 2020
- Columbia, Maryland Archives- Met to discuss future digitization projects. November 17th, 2020
- Maryland Art Place- Met to discuss potential digitization project in advance of their 40th Anniversary, Nov. 20th, 2020.
- Photographs of the Maryland Department- We continue to add items to this collection again
 with the help of a volunteer who is working remotely. Over 1,300 photographs have been
 scanned, fully described and made available.

- Sandy Spring Archives: Our partner institution continues to aggressively scan and add materials to their collection. The collection now includes over 1,200 items many of which are ledger books, autograph books or other multipage items.
- Star-Spangled Banner House collection- We have scanned and are working on metadata records for roughly 50 new items as part of the Star-Spangled Banner House collection. This includes ephemera, photographs and other items from the collection.
- Emory Grove, Grove Camp Meeting Collection- Scanned and uploaded a hotel register from Emory Grove that covers the years 1887-1891. Useful for genealogists and researchers
- Mutual Benefit Society Collection- Basis of the collection will be three ledger books from the R.F. Lewis Museum. The first has been scanned and uploaded to Digital Maryland. The "Death Register" documents member deaths and payouts from June of 1938 through December of 1947. This will be an extremely valuable tool for genealogists and has significant research potential.
- The Maryland Women's Heritage Center signed a Digital Maryland agreement on May 12, 2021. Scanning of items related to Women's History in Maryland are underway.

Additional

- Digital resources for students shared statewide: The Children's and Teen staff compiled a guide of the digital resources available through SLRC that has been shared statewide to support home learning during the COVID crisis.
- Working with the Enoch Pratt Web team to update the Digital Maryland website. The new website will have a refreshed look and will make it easier to highlight new and existing collections.
- New Digital Maryland website has been launched. The site has a refreshed look and the search bar is much easier to locate. One of our partners wrote, "The website revamp is amazing, so much more contemporary looking! I really love the aesthetic. Best part though is the new placement of the search bar. That is HEAPS more accessible and obvious. That was the biggest criticism we received over the past few months as people have been exploring our collection, an important improvement to be sure."

Increase awareness, communication and consultation for the State Publication Depository and Distribution Program (SPDDP) and the newly implemented electronic only subscription option. SLRC Strategic Plan Objective 2.4 Increase awareness of Digital Maryland and maintain support of local digitization efforts. (I)

State Documents:

- Planning has begun for a virtual meeting which will tentatively be held on Nov. 6th, 2020.
 The meeting will include general updates for the State government documents programs and how they have been affected by COVID, a tour of the new Pratt website and a presentation about quarantine procedures and the REALM study.
- The State Publications Depository & Distribution Program held its annual meeting, virtually, on Friday November 6, 2020. In attendance were participants from University of Maryland College Park, University of Baltimore, Salisbury University, Frostburg University Maryland Legislative Services, Maryland State Law Library, and Maryland State Archives. Chelsea Shockley gave a presentation on the REALM Study and quarantine procedures. We discussed updates for the program, how COVID-19 has affected their institutions, and resuming shipments.
- Government Documents staff have been in communication with State documents program partners regarding ability to resume accepting physical shipments
- Government documents department continues to add between 150-200 new documents to the Digital Repository every month
- Shipments have resumed to our partner institutions who can receive physical copies.
- Documents staff is continuing to communicate with our partner organizations and shipping
 documents to those that are able to receive. In addition, staff is working to establish
 communication with the State agencies regarding their intent to return to physical
 publications or if they intend to continue digital only.
- During March-April we added 461 born digital documents to the State Documents Repository and shipped 39 physical titles
- During the period between May-June 240 physical titles were shipped and 146 born-digital titles were added to the State documents repository.

SLRC staff are presenting at the extended virtual MLA conference:

Entrepreneur Academy - Learn about how Enoch Pratt Free Library and Baltimore County Public Library are working together regionally to establish unified service for budding and new entrepreneurs. October 13, 2020

Registration for the winter Entrepreneur Academy launches January 25, 2021. The Western Maryland Regional Library and its member libraries are part of this winter cohort. Customers across the Western Maryland region will join the Baltimore City and Baltimore County customers for this virtual program.

The winter cohort launched on February 22, 2021 with registration at 181. Current attendance is 151, a distinctly lower drop off rate than in all previous EA cohorts. This cohort includes customers from Baltimore City, Baltimore County, and Western Maryland libraries. Post-COVID EA will become a hybrid program continuing this extended reach.

Pratt/SLRC and Baltimore County Public Library staff provided a presentation and the EA Toolkit to librarians from the Prince George's Memorial Library System and the Anne Arundel County Public Library who are planning to launch a regional EA between the two systems.

SLRC staff collaborated with colleagues from Howard County Library System, and Maryland Humanities, in December to present "National History Day and You! This attendance is similar to what we would have seen with an in-person event, with higher attendance at individual sessions.

Session slides and recordings have been made available to conference attendees.

Note:

The unprecedented COVID-19 pandemic resulted in a reduction in requests for SLRC training as SLRC and all Maryland public libraries pivoted to a new year long shift to a total virtual environment. SLRC trainings reached 36% more Maryland library staff than in FY 20.

Looking ahead SLRC training and programming will remain flexible as COVID-19 restrictions change; however, virtual programs and trainings for FY 21 will be offered as hybrid programs in order to continue to reach an extended audience.

New Program Partnership

Lunch and Learn Series presented in partnership with the Maryland State Archives and the Maryland Four Centuries Project. This exciting new series explores Maryland history in context to today.

- What Role Should Archivists Play in the National Debate over Public Monuments?

Getting Started with Bilingual Storytimes






Exploring Natural Sciences with Children












State Publications Depository & Distribution Program Report

Overview

Over the past few years, State Publications and Distribution Program (SPDDP) has worked to maintain the core elements of the program while responding to participant concerns about access, sustainability and of course, space. The COVID-19 crisis has solidified the importance of a hybrid approach to ensure access to Maryland State documents. We have worked to improve electronic access while consistently communicating with SPDDP participants regarding the status of physical publication delivery.

FY 20

- 4,126 state publications copies distributed
- 2,421 publications harvested electronically

FY 21 (to date)

- 1,482 state publications copies distributed
- 2,056 publications harvested electronically

Introduction of Participation Options

In order to provide increased flexibility for our program participants, we developed options that allow for participation at different levels. Participants are now able to choose to receive print only, electronic only, or a combination of both. Those that participate electronically must add a link to the SPDDP's repository on their library's page. The new options were introduced at the annual SPDDP meeting held in November of 2019. After the initial introduction, the new subscription options took effect on Monday February 3, 2020.

Effects of COVID-19 & Improved Electronic Access

March 2020, Enoch Pratt Free Library closed its doors to the public. During that time, SPDDP received no state publications and suspended all shipments to our participants. Staff continuously harvested electronic publications for inclusion in the SPDDP repository, totaling 2,056 publications so far this fiscal year.

In addition to harvesting new publications, staff worked to identify and fix over 1,300 of inactive links in repository records. This work continues and reviewing links will become part of our regular workflow.

In August of 2020, Pratt launched a new website, which has allowed improved navigation to the State Documents repository. In December, we were able to update the repository's connection to Worldcat, which will greatly increase the findability of the documents.

In Fall 2020, SPDDP resumed shipping physical publications to participants who are able to receive them, a total of 7 participants. The number of State documents we receive from agencies remains low and we anticipate that the electronic harvest and presentation will remain crucial.

In the coming months we will continue to harvest electronic state documents, clean up metadata in the repository, and periodically check in with our participants. We will monitor the reopening of our participant's libraries.

Annual Meeting, November 2020

On November 6th we held the SPDDP annual meeting virtually. The meeting included a recap of the current project as well as a presentation on Safe Handling of Materials by Chelsea Shockley, the Customer Experience Manager at Enoch Pratt Free Library.

Attendees discussed COVID-19 procedures at their respective institutions and ways they were meeting demands for materials through scanning or modified lending procedures. Some participants inquired about the ability to update and track when new electronic versions of State documents are uploaded to agency sites. For print publications, there are update or errata sheets. This is not always the case with electronic publications. We are researching various web page notification tools to address this issue. We are also investigating the availability of MARC records for electronic publications.
